under the authority of the federal acquisition regulation (far), the department of commerce's (department) contractor personnel policies and procedures are set forth in department acquisition handbook (dah) 2-1. the dah 2-1 is the same as the opm standard operating procedures (sop) for acquiring and contracting personnel services. the dah 2-1 is applicable to all departmental offices and all contractors performing work or services for the department. (opi, office of human resources management). the opi is responsible for preparing, clearing, issuing, and maintaining the handbook or manual in accordance with section 5.2 of this order. the opi will ensure that the handbook or manual is issued in a timely manner, but it is the responsibility of the opi to determine how long it will take to prepare and issue a manual or handbook. (opi, office of human resources management). the department of commerce labor-management relations (lmr) handbook revises the departments policy and procedures concerning the departments labor relations program to be consistent with developments in law, regulations, and case law by appropriate authorities. it establishes the framework for the departments lmr program and the responsibilities of the departments labor relations staff.
